#### II. PARCEL TAX UPDATE

## A. Report on Parcel Tax Collections/Exemptions

Ms. Aragon reviewed the report for expected parcel tax collections and exemptions for 2014-2015 and 2015-2016. Mr. McSweeny asked how parcel numbers can increase. Ms. Aragon said new construction and dividing of parcels are likely the cause. Exemptions decreased slightly as ownership may have changed.

## **B.** Report on Expenditures

Ms. Aragon reviewed the Expenditure Report for 2014-2015 (33 teachers and 3 counselors) and 2015-2016 (31 teachers and 3 counselors). The budget remained the same for both years. Mr. Sylvia asked if the District is considering another parcel tax. Ms. Aragon said the Board has expressed a high interest. Currently, they are in the planning stage for a new parcel tax as you cannot renew a parcel tax. Ms. Whitaker asked how many teachers would be let go if the new parcel tax does not pass. Ms. Aragon said a discussion would have to take place regarding what type of budget reductions would be required and how they would impact the District. Mr. Parrille asked what the projected student population will be for the next 2-3 years. Ms. Aragon said projections are for stable enrollment.

Ms. Aragon shared the 14-15 Los Angeles County Unified Schools Unduplicated Count, which includes English learner, free and reduced, and foster children, as well as

the homeless. Districts with 55% or more unduplicated pupil counts receive more funding. Arcadia's unduplicated pupil count is 29%.

## A. Draft Review of 2014-2015 Annual Report to Governing Board

Ms. Aragon shared a draft of the 2014-2015 Annual Report and the Committee said it looked good.

Ms. Stiles expressed how important it is to talk about athletics when considering a new parcel tax.

Ms. Aragon asked if the Committee would support the measure should the District decide to pursue another parcel tax. Mr. McSweeny said he would support it as the benefits outweigh the cost. Mr. Sylvia would support it as property values would increase. Ms. Stiles, Ms. Tom and Mr. Yamada also expressed support of the measure. Mr. Parrille mentioned that, in April, there will be something on the ballot to eliminate the utility tax; property and business owners will be receiving a statement from the City to show what tier they are on.
